### Fremont Township Minutes November 14, 2019

The regular meeting for the Fremont Twp. Board of Trustees was held on November 14, 2019, at 7:00 p.m. at the Fremont Township Hall.

**MINUTES:** Motion made by C. Sherwin, seconded by A. Holbrook to approve the October 10, 2019, regular meeting minutes as presented - motion carried.

BILLS: Motion to pay the bills as presented made by C. Sherwin, seconded by R. Curell - motion carried.

## **PUBLIC COMMENTS:**

Carrie Will mentioned that she was at the Board meeting as part of her requirement for the Tuscola LEAD Program.

# **CLERK REPORT:**

A. Holbrook did not have anything at this time but had information when we discuss the security cameras for the township hall.

## **TREASURER REPORT:**

Treasurer balance as of October 31, 2019, was \$344,734.52. Motion to accept the treasurer report made by A. Holbrook, seconded by C. Sherwin - motion carried.

## **SUPERVISOR REPORT:**

M. Blatt got an estimate for installing security cameras at the Hall. A. Holbrook talked to someone from the PAR Plan which is part of our insurance company and they stated that they offer grants for things like security cameras. All we would need to do would be to pass a resolution allowing the Clerk to submit the application, and then submit a copy of the resolution with the completed application and bid to the PAR Plan. Motion made by C. Sherwin, seconded by R. Curell to approve the Grant Resolution to allow the Clerk to apply for a grant for security cameras at the Hall. Roll call vote: R. Curell-yes, M. Blatt-yes, A. Holbrook-yes, C. Sherwin-yes. Motion carried.

Road Report – M. Blatt met with four members of the Road Commission to discuss the township roads. After driving the roads it was decided that there is three miles of Washburn Road that is the worst and should be a priority. M. Blatt is going to get an estimate from the Road Commission for these three miles and also confirm that we can get the \$25,000 matching funds if we do this project. M. Blatt is also going to get an estimate for brush spraying because the Road Commission states that brush spraying is more effective than even roadside brush mowing. M. Blatt also following up with some complaints about some roadside ditches. He is going to get an estimate from the Road Commission for cleaning some areas along North Lobdell, South Lobdell, Chambers, and Blackmore. It was asked about possibly cleaning the ditch near Cat Lake and Harmon Lake Road. M. Blatt stated that area is the responsibility of Dayton Township.
