Wanted to check in to see if there was any questions regarding the American Rescue Plan, Building Codes, or Golf Cart Ordinance. The Board of Commissioners will be having a public hearing regarding the Golf Cart Ordinance and then once it is passed it will be up to the Townships to also pass similar ordinances.

BILLS:

PUBLIC COMMENTS:

A Resident asked if the cost of the phone bill was just for one month. M. Blatt stated that it is and as soon as we can get faster internet we will be looking into VOIP (Voice Over Internet Protocol) for phones but at this point that is the only option that we have. Another Resident asked if we were going to get bids for roadside mowing and M. Blatt stated that we will be putting it out for bids.

CLERK REPORT:

A. Holbrook stated that she has been told that we will be having an August 3, 2021, election because the Mayville School has filed certification to place a proposal on the ballot.

TREASURER REPORT:

Treasurer balance as of March 31, 2021, was \$323,382.90. Motion to accept the treasurer report made by K. Thom, seconded by R. Curell - motion carried.

Treasurer balance as of April 30, 2021, was \$292,412.51. Motion to accept the treasurer report made by K. Thom, seconded by A. Holbrook - motion carried.

SUPERVISOR REPORT:

Cemetery Report – Had two burials this month. Also the Caretaker has finished taking down the approved trees. He has also gotten the water turned on at the cemetery.

Road Report – M. Blatt received bids from the Road Commission for Schott Road, O'Brien Road, Cat Lake Road and also for township wide brush spraying. M. Blatt is still waiting for a bid on spot gravel. Motion made by R. Curell, seconded by K. Thom to approve \$143,280.40 for Schott Road from Snover to Blackmore – motion carried. Motion made by A. Holbrook, seconded by M. Blatt to approve \$12,500 for township wide brush spraying – motion carried. Motion made by R. Curell, seconded by M. Blatt to approve \$34,451.08 for O'Brien Road from Washburn to Chambers – motion carried. Motion made by K. Thom, seconded by R. Curell to approve \$17,347.44 for Cat Lake Road from Blackmore to Mead – motion carried.
