

**Fremont Township Minutes
February 8, 2018**

The regular meeting for the Fremont Twp. Board of Trustees was held on February 8, 2018, at 7:00 p.m. at the Fremont Township Hall.

MINUTES:

Motion made by M. Blatt, seconded by J. Welke to approve the January 11, 2018, regular board meeting minutes as presented – motion carried

BILLS:

Motion to pay the bills as presented made by C. Sherwin seconded by M. Blatt – motion carried.

PUBLIC COMMENTS:

A Resident asked that the Board revisit the idea of putting the names of all the people that attend the meetings in the meeting minutes. It was suggested that maybe we could just scan the sign-in sheet and include that with the minutes but the Resident stated that they would prefer that the names were actually printed in the minutes.

TREASURER REPORT:

Treasurer balance was \$381,349.42 as of January 31, 2018. Motion to accept treasurer report made by A. Holbrook, seconded by J. Welke – motion carried.

SUPERVISOR REPORT:

Cemetery Report – There is a Cemetery Committee meeting scheduled for February 19th at 5 p.m. Also sold \$400 worth of cemetery lots.

Road Report – H. Wymore is going to request a bid from the Road Commission to resurface Blackmore Road from Conrad to Leix as this is one of the oldest miles and also has a couple culverts that are sinking.

NEW BUSINESS:

H. Wymore stated that he is unsure about doing the tire collection this year because they want to drop off the trailer on a Monday for a Tuesday or Wednesday tire collection and then not pick up the trailer until Friday. H. Wymore is concerned that we will end up with a lot of tires left at the hall while the trailer is just sitting there because that is what usually happens when the trailer is just dropped off the day of the collection. The Board members stated that it was fine not to do the tire collection because our residents can take them to any other Township in the County that holds a collection. It was suggested that when we get the dates for the tire collections that we post a copy on the bulletin board.

There is Board of Review training on February 9th that all the board of review members are attending. Board of Review dates for March are as follows: Organizational meeting March 7th at 7:30 pm, March 12th from 9am - noon and 1pm - 4pm and March 16th from 2pm - 5pm and 6pm - 9pm.
