Fremont Township Minutes December 11, 2025

The regular meeting for the Fremont Twp. Board of Trustees was held on December 11, 2025, at 7:00 p.m. at the Fremont Township Hall.

Board members present: M. Blatt, A. Prill, R. Curell, B. Blatt, and C. Franzel. Absent: None. Guests: Ken Bragg, Greg Eggert, Gail Prill, and Terry Blackmer (Mayville Fire Chief).

MINUTES:

Motion made by B. Blatt seconded by R. Curell to approve the November 13, 2025, regular meeting minutes as presented – motion carried.

BILLS:

Motion to pay the bills as presented made by C. Franzel, seconded by R. Curell - motion carried.

PUBLIC COMMENTS:

A Resident questioned why we are paying an electric bill for the cemetery and A. Prill stated that it is for the well at the cemetery.

M. Blatt asked the Fire Chief if he had anything to talk about and he stated no. The Fire Chief did state that they are almost to their highest number of runs in a year.

CLERK REPORT:

Zoning Report - In November the Zoning Administrator issued two citations, two permits and also received four new complaints.

Policy and Procedures – A. Prill is still working on these and will hopefully have them to the board members in the next few weeks.

TREASURER REPORT:

Treasurer balance as of November 30, 2025, was \$305,374.83. Motion to accept the treasurer's report made by B. Blatt, seconded by A. Prill - motion carried.

SUPERVISOR REPORT:

Cemetery Report – M. Blatt stated we will wait on the bridge project until the weather warms up. Road Report – M. Blatt stated that he still has not gotten any information regarding Phelps Lake Road. He did talk with a survey company and was told that they could shoot grade for around \$350-\$500. This way we would know what it would take to put in a tile. Motion made by R. Curell, seconded by A. Prill to spend up to \$1,000 to have the survey company shoot grade on Phelps Lake Road – motion carried. M. Blatt stated that he received a message from the Road Commission stating that they are planning to pave Mertz and Brown Road this next year. They stated in their letter that if the township is interested they could include the remaining Brown Road cutoffs which would require about 80 tons of asphalt and cause around \$14,300. M. Blatt stated that he will submit a work order for this project.

NEW BUSINESS:

M. Blatt stated that he did talk with someone about stripping and polishing the hall fall. The guy is interested in the job and will get us a price.
