### **MINUTES:**

# **CLERK REPORT:**

- Private Road & Driveway Easement Ordinance: Motion made by J. Meyer, seconded by I. Barrons to adopt the Private Road & Driveway Easement Ordinance – Roll call vote: J. Meyer-yes; A. Holbrook-yes; I. Barrons-yes; H. Wymore-yes. Motion carried.
- Industrial Facilities Exemption: J. Meyer mentioned that this was an exemption put into place for a new business and this business was already in the township but moved to a new location. She also stated that it would not be a huge revenue loss for the township. Motion made by I. Barrons, seconded by J. Meyer to waive any objections for the Industrial Facilities Exemption for Northern Log Supply motion carried. A. Holbrook did not vote due to conflict of interest.

Treasurer balance was \$82,586.65 as of December 31, 2009. Motion to accept treasurer report by J. Welke, seconded by I. Barrons – motion carried. CD is coming due at MSB – will let it renew for another 6 months. Treasurer asked if the township had a policy for returned NSF checks – she will get a sample policy.

### **SUPERVISOR REPORT:**

Received a call from a resident who lives on the outskirts of the Village and since the Village will not take grass clippings anymore they feel the township should.

### **NEW BUSINESS:**

Received letter from the Tuscola County Recycling Facility regarding setting up a Collection Site – will contact them to see if they think it would be beneficial for the township to do.
