### **MINUTES:**

Motion made by C. Franzel, seconded by R. Curell to approve the March 10, 2022, meeting minutes as presented - motion carried.

#### **BILLS:**

Motion to pay the bills, except check 14645 for Kyle Thom, made by C. Franzel, seconded by R. Curell - motion carried.

# **PUBLIC COMMENTS:**

A Resident stated that they have done some research on the ARPA (American Recovery Plan Act) guidelines and stated that in order to spend the money the townships have to have public input; it is required. This Resident also spoke about the economy, employment rates and unemployment rates.

# **CLERK REPORT:**

A. Holbrook mentioned that she gave the Board Members a copy of the Zoning Administrator's report and he issued one permit for removal of a mobile home. A. Holbrook also mentioned that we are still waiting to hear back from the County Planning Commission regarding the updated marijuana ordinance proposed by the Township Planning Commission. ## **TREASURER REPORT:**

Treasurer balance as of March 31, 2022, was \$636,720.78. Motion to accept the treasurer report made by A. Holbrook, seconded by R. Curell - motion carried.

## **SUPERVISOR REPORT:**

Cemetery Report – Caregiver would like to replace the water spigots at the cemetery before we turn the water on for the season. Last year a lot of them were leaking. There are 13 total and the cost would be \$175 for supplies and \$100 for labor. The Caregiver would also like to remove 6 trees from the Fremont Cemetery on the east side and a clump of three trees on the west side for \$200 total. Motion made by A. Holbrook, seconded by C. Franzel to approve the \$275 for replacement of the spigots and \$200 for removal of the trees. Roll call vote: R. Curellyes, C. Franzel-yes, A. Holbrook-yes, M. Blatt-yes. Motion carried.

Road Report – Received the bid for scrub seal on Snover Road from Leix to M-24 for \$78,327.52. Motion made by R. Curell seconded by M. Blatt to approve the work to be done on Snover Road – motion carried. M. Blatt stated that he also received two bids for roadside mowing. He received a bid from Discrete Services for \$4,000 and Complete Home Repair for \$5,000. Motion made by R. Curell, seconded by A. Holbrook to accept the bid from Descrete Services for \$4,000. Motion carried.
