

Fremont Township Minutes January 8, 2026

The regular meeting for the Fremont Twp. Board of Trustees was held on January 8, 2026, at 7:00 p.m. at the Fremont Township Hall.

Board members present: M. Blatt, A. Prill, R. Curell, B. Blatt, and C. Franzel. Absent: None.

MINUTES:

Motion made by B. Blatt seconded by R. Curell to approve the December 11, 2025, regular meeting minutes as presented – motion carried.

BILLS:

Motion to pay the bills as presented made by C. Franzel, seconded by B. Blatt - motion carried.

PUBLIC COMMENTS: None

CLERK REPORT:

Zoning Report - In December the Zoning Administrator issued two citations, two permits and no new complaints. He is continuing to follow up on several complaint investigations.

Budget Meeting - A. Prill stated that we need to schedule the budget meeting which usually takes place after the February regular board meeting. The Board agreed that we should hold the budget meeting after the regular February 12th meeting.

Policy and Procedures – A. Prill handed out a draft version of the proposed policy and procedures for the township. Motion to accept the clerk's report made by B. Blatt, seconded by R. Curell – motion carried.

TREASURER REPORT:

Treasurer balance as of December 31, 2025, was \$147,455.64. Motion to accept the treasurer's report made by A/ Prill, seconded by B. Blatt - motion carried.

SUPERVISOR REPORT:

Road Report – M. Blatt stated that he did turn in the work request to the Road Commission to get an estimate on the Brown Road project. He also stated that he is going to hold off on the Phelps Lake project until the weather is nicer so that the surveyor can get out there.

NEW BUSINESS:

B. Blatt stated that at the Planning Commission meeting it was discussed that they should have the township attorney attend all their meetings. G. Eggert (Planning Commission Chairperson) stated that he did not think it was necessary for the attorney to be at all meetings. M. Blatt agreed with G. Eggert and A. Prill thought the attorney should only attend on an as-needed basis. Motion made by B. Blatt, seconded by R. Curell to have the township attorney attend the planning commission meetings on an as-needed basis – motion carried.
